 - **3.1** Reservation will be done as per prevailing provisions at Government of India Institutes and as amended from time to time.
 - **3.2** OBC reservation will be made as per "Central List of OBC."
 - **3.3** Eligibility of the candidates with disabilities will be decided by a Board of the Institute constituted for the same.

- 4. Language of Study: English
- 5. Eligibility:
 - **5.1** The candidate must be an Indian National.
 - **5.2 Master of Physiotherapy (MPTh)** course is open for admission to Physiotherapists holding a Bachelor's Degree in Physiotherapy, from a recognized University, with completion of six months compulsory internship.
 - **5.3 Fellowship Course in Rehabilitation Physiotherapy (FCRPT)** is open for admission to Physiotherapists holding a Bachelor's Degree in Physiotherapy, from a recognized University, with completion of six months compulsory internship.
 - **5.4 Master of Occupational Therapy (MOTh)** course is open for admission to Occupational Therapists holding Bachelor's Degree in Occupational Therapy from a recognized University, with completion of six months compulsory internship.
 - **5.5** Fellowship Course in Rehabilitation Occupational Therapy (FCROT) is open for admission to Occupational Therapists holding Bachelor's Degree in Occupational Therapy from a recognized University, with completion of six months compulsory internship.
 - 5.6 Candidates who have done Bachelor's degree from Agricultural University and Distance Education are not eligible as per Directorate of Medical Education and Research (DMER) / Maharashtra University of Health Science (MUHS) guidelines.
 - **5.7** Date of completion of Internship : on or before 30/09/2025
 - **5.8** Candidate must be registered with Maharashtra State Occupational Therapy & Physiotherapy Council and should mandatorily submit the Valid registration certificates for Masters and as



- well as Fellowship courses. For Candidates from out of Maharashtra, time will be given to obtain the same with payment of late fees to University.
- 5.9 Eligibility to the candidates admitted for the course is granted by Maharashtra University of Health Sciences, Nashik, and Institute takes no responsibility for the same. It is not assured by the institute at the time of admission that university will grant eligibility to the candidate.

6. Prospectus and Application form:

- **6.1** Prospectus and Application form can be downloaded from Institute website i.e. www.aiipmr.gov.in. Duly filled in application form can be forwarded to the Institute along with Application.
- **6.2** The application form is common for all courses i.e. for Master of Physiotherapy, Fellowship course in Rehabilitation Physiotherapy, Master of Occupational Therapy and Fellowship course in Rehabilitation Occupational Therapy. Candidates are supposed to mark **'Yes'** in the appropriate box while filling up the Application Form.
- **6.3** Application fee of Rs. 800/- for each course has to be paid along with application form. For SC/ST/PH Candidates application fee is relaxed to Rs. 600/-. If a candidate wish to apply for two courses (i.e. for Masters and Fellowship courses), total amount to be paid towards application fee is as follows:
 - 6.3.1 For General/OBC Category candidates Rs-1550/-
 - 6.3.2 For SC/ST/PH Category candidates Rs. 1150/-

*Fee of application form received after due date would not be refunded.

- 6.4 The candidates belonging to Reserved (SC/ST/OBC/PH) categories who had claimed so in his/her application form, should submit self- attested / certified copies of the relevant certificates [caste certificate/ caste validity certificate/ OBC (valid Non-Creamy layer certificate valid up to 31/03/2026) / disability certificate] applicable, along with the original of the same, issued by competent authority at the time of admission compulsorily. (Those candidates who have applied for the applicable certificates should produce the proof of the application in original and should declare that if the certificates is not made available before submission of enrollment and eligibility form to the University, the admission may be treated as cancelled)Note- In casecaste Validity Certificate is not issued by a state they should obtain a Certificate issued by competent authority As per annexure-III.
- **6.5** Applicants should write their name, course name and contact number on the back side of the Demand Draft / Pay Order.
- **6.6** Applicants should keep a photocopy of demand draft with them for future reference.
- **6.7** 'Application form fee' is **non-refundable** and **non-transferable** under any circumstances.



- 6.8 Even if form is downloaded from website, application fee should be submitted at the time of sending the application forms as mentioned above.
- 6.9 All Payments will be accepted in the form of Demand Draft/ Pay Order drawn in favour of 'Director, AIIPMR' Payable at Mumbai from any nationalized bank only. Payment in any other form will not be accepted.

7. Submission of Application Form:

- **7.1** Duly filled in application form and admit card (in duplicate) along with 'Application form fee/Prospectus fee' can be submitted in room no. 201, 2nd floor during office time (Monday Friday 9.00 am to 4.00 pm, Saturday 9.00 am to 1.00 pm) **or** can be sent by post on Institute's address on or before **04/09/2025**.
- **7.2** Candidates are supposed to attach a self- addressed envelope of size 23cms. X 11.5cms affixing postage stamp of Rs. 60/-superscripted 'Admit card for (Name of the course)' and should be enclosed along with the application form.
- **7.3** Photograph on the application form and on the admit card should be same and should have been taken within the last 6 months.
- **7.4** All correspondence will be done on correspondence address furnished by applicant in the application form.
- **7.5** In case of personal submission and if applicant requires acknowledgment of submission of application form he /she should bring a photocopy of filled application form on which acknowledgement will be provided.
- 7.6 Incomplete application forms / application forms received after last date of submission will not be accepted. Fees once paid is nonrefundable/ nontransferable under any circumstance and no communication in this regard will be entertained. Last date of receipt of duly filled in application form is as mentioned in Annexure-I.

8. Admit Card:

- **8.1** Admit Card will be sent by post to the eligible applicants which will be received approximately 10 days prior to the date of entrance examination.
- **8.2** In case of delay or non-receipt of Admit Card, candidate can collect the Duplicate Admit Card from the examination center on the day of the entrance examination on producing photocopy of Demand Draft.
- **8.3** Candidates have to appear for the Entrance Test at their own expenses and make arrangements for their accommodation in Mumbai on their own. No communication in this regards will be entertained.
- 8.4 Without Admit card candidate will not be allowed to enter in the examination hall.



9. ENTRANCE TEST:

9.1 Entrance test pattern: Entrance test will be for 1 ½ hour duration of Total100Marks.

9.2 Each question carries equal marks. There will be no negative marking. Entrance Test will consist of 100 Multiple Choice Questions (MCQs) for each stream, based on syllabus taught at under graduate level & will have three sections:

Section I - Medical Section - 50 Marks
Section II - Occupational Therapy Section - 50 Marks
Section III - Physiotherapy Section - 50 Marks

Section - I is compulsory for all candidates and will cover questions on basic medical subjects taught at undergraduate level i.e. Bachelor of Physiotherapy/ Bachelor of Occupational Therapy.

Section – **II** will be answered by those candidates who have applied for Master of Occupational Therapy/ Fellowship course in Rehabilitation Occupational Therapy course.

Section – **III** will be answered by those candidates who have applied for Master of Physiotherapy/ Fellowship course in Rehabilitation Physiotherapy course.

9.3 Each Question will have 4 choices (A), (B), (C) and (D) out of which one is correct. Candidates have to write the correct answer in the given box against the question. Candidates should not use any other method for answering (Use blue/ black ball point ink only).

9.4 Syllabus for all three sections will be based on undergraduate level i.e. Bachelor of Physiotherapy/Bachelor of Occupational Therapy syllabus of Maharashtra University of Health Sciences (MUHS), Nashik which is available on **MUHS website www.muhs.ac.in**

9.5 There will be no **rechecking /re-evaluation** for the Entrance Test answer sheets. However candidate can apply for verification of marks by giving an application on plain paper, within **four days** of declaration of Entrance Test results, along with application fee of **500/-** in the form of Demand Draft to be Drawn in favour of **'Director, AIIPMR' Payable at Mumbai.**

9.10.Time of Examination: 11.00 am to 12.30 pm

9.11. Venue of the entrance examination will be intimated via the Admit Card.



- **9.12.** It is mandatory to carry one original photo identity proof along with the admit card on the day of examination.
- **9.13.**Mobile phone, calculators and any other electronic devices will not be permitted in the Examination Hall.
- **9.14.**Calculations/ rough work can be done on a separate paper provided with the main booklet.
- **9.15.**Overwriting or changing an answer is not permitted. The Candidates must fully satisfy themselves about the correctness of the answer before writing the alphabet in the blank box.
- **9.16.**No change in the answers once written is permitted and the same will be treated as invalid / incorrect response and no marks will be awarded for the same.
- **9.17.** Date of declaration of result of Entrance Examination will be uploaded later, on the Institute notice board and Institute Website:
- **9.18.**Date of declaration of list of selected candidates: information will be uploaded on the Institute website- www.aiipmr.gov.in
- **9.19.**Selection of candidates will be provisional, and final eligibility will be granted by the MUHS, Nashik.
- **9.20.** All Candidates are hereby instructed to keep checking the Institute's website/ Notice board for details regarding merit list/ selection list/ waiting list/ any instructions/ updates periodically.
- 10. STIPEND IS NOT ADMISSIBLE FOR ANY COURSE CONDUCTED BY THIS INSTITUTE.

- **12.2**.All payments should be made in the form of Demand Draft/ Pay Order drawn in favour of 'Director AIIPMR' payable at Mumbai. Payment in any other form will not be accepted. Candidates are requested to write their name, course name and contact number on the back side of the DD.

14. <u>Cancellation of admission For Master of Physiotherapy / Master of Occupational Therapy courses / For Fellowship course in Rehabilitation Physiotherapy / Fellowship course in Rehabilitation Occupational Therapy courses:</u>

- **14.1.**If a candidate cancels his/ her admission before the cut –off date (declared by MUHS, Nashik. / D.M.E.R., Government of Maharashtra) the security deposit of Rs.1000/-(Rupees one thousand only) will be forfeited as administration charges & rest of the fees will be refunded.
- **14.2.**If the student cancels his/her admission after cut-off date of admission (cut-off date declared by the University, D.M.E.R., Govt. of Maharashtra); full amount of fees paid will be forfeited including deposits. This is for all candidates i.e. candidate admitted under All India Quota as well as under Maharashtra State Quota (Selected by DMER).
- **14.3.**Admission will be cancelled on submission of 'No-Due' Certificate issued by the Librarian/ Hostel Warden /Head of Department along with student's application.



15. SUBMISSION OF BOND

Candidates admitted for MPT/MOT/FCRPT/FCROT Course will be compulsorily required to submit surety Bond of Rs. 300000/- (Rupees Three lakh only) on Rs.100/- stamp paper with Notary. Candidates will be required to pay Rs. 300000/- (Rupees Three lakh only) for not completing the course or for cancellation of admission after the Cut-off date declared by MUHS, Nashik /DMER, Govt. of Maharashtra. (In addition to the amount mentioned in Sr.No. 12.1 or 13.1 above)

16. Hostel:

The Institute has limited hostel facility. Allotment is done by the Hostel Committee, as per laid down criteria by the Institute authority. Students are at liberty to make their own arrangement as the Institute authorities don't insist on compulsory hostel stay.

17. Conduct & Discipline:

- **17.1.**Failure of the candidate in making full and correct statements in the application form and/ or suppression of any information would lead to disqualification of the candidate for the course, at any given point of time.
- **17.2.** Adopting any unfair means or engaging in malpractice in the examination hall is strictly prohibited.
- 17.3.Ragging in any form is prohibited and is a punishable offence as per Honorable Supreme Court's directives no. "CIVIL APPEAL NO. 887 OF 2009". The student is liable to be rusticated if found involved in ragging.
- 17.4.In any issue other than dealt with above, the decision of Institute's authorities will be final.
- **17.5.** Any disputes arising out of admission process will be under legal jurisdiction of Mumbai High Court only.
- **17.6.**At the time of admission the candidates have to submit on undertaking on UGC web portal-www.antiragging.in

19. Number of seats available:

19.1. For Master of Physiotherapy course under 'All India Quota': 3(Three)

Institute has total intake capacity of Six seats, out of which 3(Three) seats are for candidates who have passed Bachelor of Physiotherapy from Anywhere in India including Maharashtra to be selected though Entrance Test conducted by this Institute. Remaining 3 (Three) seats are for Maharashtra candidates who have passed Bachelor of Physiotherapy from Universities in Maharashtra to be selected through entrance test conducted by Directorate of Medical Education & Research (DMER)-Government of Maharashtra.

19.2. For Master of Occupational Therapy course under 'All India Quota': 2 (Two)

Institute has four seats permitted by University, out of which two seatsare for candidates who have passed Bachelor of Occupational Therapy from Anywhere in India including Maharashtra to be selected though Entrance Test conducted by this Institute. Remaining 2 (two) seatsare for Maharashtra candidates who have passed Bachelor of Occupational Therapy from Universities in Maharashtra to be selected through entrance test Conducted by Directorate of Medical Education & Research (DMER)-Government of Maharashtra.*
