1. Name of the Post : Staff Car Driver (Ordinary Grade)
2. Pay Scale of the Post : Level-2 (Rs. 19900-63200) in pay matrix.
3. No. of posts: 02
4. Mode of recruitment : (i) Deputation or Absorption

From amongst the regular Dispatch Rider (Group 'C') and Group 'C' employees in level 1 of the pay matrix (Rs. 18000-56900) in the All India Institute of Physical Medicine and Rehabilitation, Mumbai who possess valid driving license for motor cars on the basis of a driving test to assess the competence to drive motor cars failing which from officials holding the post of Dispatch Rider on regular basis in level 1 of the pay matrix (Rs. 18000-56900) in other Ministries of the Central Government who fulfil the necessary qualifications as mentioned in Sl. No. 5 of this advertisement.

(ii) Deputation or re-employment for Armed Force Personnel

The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed in Sl. No. 5 of this advertisement shall also be considered. Such persons would be given deputation terms upto the date on which they are due for release from the Armed Forces, thereafter they may be continued on re-employment.

Note-1 : The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceeding three years. The maximum age-limit for deputation shall be not exceeding fifty-six years as on the closing date of the receipt of application.

5. Required qualification:**Essential:**

- (i) 10th standard pass from a recognised Board.
- (ii) Possessing a valid driving license for motor cars; and
- (iii) Experience of driving a motor car for at least three years;
- (iv) Knowledge of Motor Mechanism (The candidates should be able to remove minor defects in vehicle)

Desirable: Three years' service as Home Guard or Civil Volunteers.
