Course Specific Information

Bachelor of Prosthetics and Orthotics:

The **Bachelor of Prosthetics and Orthotics** (**B.P.O**) course is an undergraduate degree course under the category of Allied Healthcare. This course focuses on the specialized profession of **Prosthetics & Orthotics** which involves designing, fabricating and fitting Prostheses (Artificial Limbs) and Orthoses (Supportive Devices and Splints) and Mobility Aids and Assistive Devices for individuals with locomotor disabilities.

Teaching of the Core subjects of Prosthetics and Orthotics, subjects from the field of Medicine like Anatomy, Physiology, Pathology, Pharmacology, Orthopaedics and Amputation Surgery as well as subjects from the field of Engineering like Applied Mechanics & Strength of Materials, Material Science & Workshop Technology, Basic Electronics and Computer Science prepare the students to help people regain or improve their mobility and quality of life.

Duration of the Course: Four and half academic years (including 6 months Internship)

Affiliation of the Course: The course is affiliated to the Maharashtra University of Health Sciences, Nashik.

Recognition of the Course: The course is approved and recognized by the Rehabilitation Council of India (RCI) which is a statutory body established by an Act of Parliament in 1992.

Language of Study: English

1. Number of seats available: Total 16 seats

1.1 08 seats are available for candidates from all over India including Maharashtra (All India Quota), who have passed their H.S.C.(10+2) or Equivalent Examination and appeared for NEET UG 2025 Examination, and scored minimum 50% Marks in PCB (for general category candidates), 40% marks (for candidates belonging to the SC/ST/OBC categories)& 45% marks (for PH category candidates).

Selection of candidates under All India Quota will be done as per the NEET score of current academic year 2025-26. Candidates domiciled in the state of Maharashtra can also apply under this quota. Reservation will be as per Government of India guidelines.

1.2 08 seats are for Candidates having domicile of State of Maharashtra (**Maharashtra state Quota**) and passed their H.S.C. (10+2) Examination from Colleges/Schools from Maharashtra State and appeared for NEET UG 2025. Selection of candidates under Maharashtra State Quota will be done by Directorate of Medical Education and Research (DMER) Mumbai, Maharashtra / CET Cell Maharashtra.

3. Admission Procedure:

3.1. Who can apply?

Eligibility:-

- **3.2** Applicants who have passed 12th Std. /10 +2 examination with English and with minimum50 % Marks in Physics, Chemistry & Biology for General Category, 40% marks for SC/ST/OBC, & 45% marks for PH category or any other candidates Examination recognized as equivalent thereto by Maharashtra State Board of Secondary and Higher Secondary Education and who have appeared for NEET UG 2025.
- **3.3** The Candidate must be born on or before <u>31/12/2008</u>. Birth Certificate or SSC (Class X) or equivalent examination certificate with the date of birth clearly endorsed shall be considered as a valid evidence.
- **3.4** Current year NEET Scores only will be considered for admission to BPO course alongwith other qualification & qualifying examination codes as per NEET marksheet-2025. Those applications not accompanied by class XII mark sheet & NEET 2025 Mark sheet will not be considered.
- 3.5 The candidate must be an Indian National.
- 3.6 Eligibility of the candidates admitted, is granted by Maharashtra University of Health Sciences, Nashik and the Institute takes no responsibility for the same. It is not assured by the Institute at the time of admission that University will grant eligibility to the candidate.

4. How to Apply:

- 4.1The students can download the <u>Prospectus and application form</u> from the Institute'swebsite <u>www.aiipmr.gov.in</u> and duly filled in application is to be sent to the institute alongwith Application fee*.
- 4.2 Please write (applicant's) name as on NEET score-sheet and course name on the backside of the Demand Draft /Pay Order along with mobile no. of the candidate.

5. Reservation:

- **5.1** Reservations will be done as per prevailing provisions at Government of India Institutes andas amended from time to time.
- **5.2** OBC reservation will be made as per "Central List of OBC."
- **5.3** Eligibility of the applicants with disabilities will be decided by Medical Board of the Institute constituted for the purpose.



6. APPLICATION FEE:

- **6.1**. Application fee for General category candidates is Rs. 600/-
- **6.2** Application fee for **SC/ST/PH** candidates is Rs. 400/-
- **6.3** All Payments will be accepted in the form of Demand Draft/ Pay Order drawn in favor of 'Director, AIIPMR' Payable at Mumbai from any nationalized bank only. Payment in any other form will be rejected.
- **6.4** The Application fee is non- refundable and non- transferable under any circumstances.

7. SUBMISSION OF APPLICATION FORM:

7.1 Duly filled in application form along with current year (2025-26) NEET Score Mark sheet, Class XII Mark sheet, certificates and DD/DO can be sent by post on Institute's address or can be submitted by hand on or before 04/09/2025.

Applicants are advised to regularly check the institute website for any addendum / Corrigendum related to the admission process.

- 7.2 Incomplete applications or applications received after last date of submission will be rejected and no fees will be refunded/ returned under any circumstances and no communication in this regard will be entertained.
- **7.3** Photographs on the application form and on the admit card should be same, clear and taken within the last six months.
- **7.4** In case of personal submission, if an applicant requires acknowledgment of submission of application form he /she should bring a photocopy of the filled in application form on which acknowledgement will be provided.
- **7.5** All correspondence will be done on the correspondence address furnished by the applicant in his/ her application form.

Application fee received after due date will not be refunded.

8.2 All payments should be made in the form of Demand Draft/ Pay Order drawn in favor of Director AIIPMR' payable at Mumbai.

Payments in any other form will not be accepted.

All applicants are requested to write their name and course name on the back side of the D.D. along with the mobile no. of the candidate.

- **8.3** After admission students can apply for scholarship through **MAHADBT** portal, **NSP**, **DMER**, and **PM Vidyalaxmi** etc. as applicable.
- **8.4** 100% of the fees mentioned in point no. 8.1 (i.e. Rs.13900/-) are to be paid at the time of admission. (Cut-off date will be declared by University / D.M.E.R., Govt. of Maharashtra).
- **8.5** All students are required to apply for refund of deposits along with the Original Fee receipt, immediately after the completion of course, else the Amount of refundable Deposits will be forfeited.
- 8.6 No stipend will be paid to the admitted candidate.

9.19 The candidate belonging to Reserved (SC/ST/OBC/PH) categories who has claimed so in his/her application form, should submit self-attested copies of the relevant certificates [caste certificate/OBC(valid Non-Creamy layer certificate valid up to 31/03/2026) / disability certificate] respectively, along with the original of the same, issued by competent authority at the time of admission compulsorily.

(Those applicants who have applied for the applicable certificates should produce the proof of the application in original and should declare that if the certificate is not made available before submission of enrollment and eligibility form to the University the admission may be treated as cancelled)

Note- In case a Caste Validity Certificate is not issued by a particular state they should obtain a Certificate issued by competent authority - As per annexure-II

Note: Candidates are instructed to obtain the necessary certificates in original well in advance as they are mandatory & have to be submitted in original at the time of seeking the admission. There may be no relaxation for submission of the same at the time of admission.

Course wise selection lists, any amendments to the above schedule and or important announcements will be made available on the Institute's website (www.aiipmr.gov.in). Candidates are instructed to visit the Institute's website from time to time.



10. Cancellation of admission for BPO Course:

- 10.1 If a candidate cancels his/ her admission before the cut –off date (declared by MUHS, Nashik / D.M.E.R., Government of Maharashtra) the security deposit of Rs.1500/-(Rupees one thousand five hundred only) will be forfeited as administration charges & rest of the fees will be refunded.
- 10.2 No refund of fees including deposits will be given if a candidate cancels his/her admission after the cut-off date i.e. admitted under All India Quota as well as under Maharashtra State Quota (Selected by DMER).
- **10.3** Admission will be cancelled on production of 'No-Dues' Certificate from the Librarian/ Head of the Department along with application.
- 10.4 Students are required to apply in prescribed format for refundable deposits immediately after final examination / completion of the course in order to get the refund.

11. SUBMISSION OF SURETY BOND

Candidates admitted to B.P.O. course will be compulsorily required to submit surety Bond of Rs.200000/- (Rupees Two lakes only) notarized on stamp paper of Rs. 100/-.

**Candidates will be required to pay Rs.200000/- (Rupees Two lakhs only) for not completing the course or for cancellation of admission after the Cut-off date declared by DMER/CET Cell, Govt. of Maharashtra as per the guidelines provided by the Commissionerate State CET Cell Information Brochure.



12. Hostel:

The Institute has limited hostel facilities. Allotment of Hostel accommodation is done by the Hostel Committee, as per criteria laid down by the Institute. Students are at liberty to make their own stay arrangements as the Institute authorities don't insist on compulsory hostel stay.

13. Conduct & Discipline:

- **13.1** Providing false information, making incorrect statements in the application form and/or suppression of any information may lead to disqualification of the candidate for the course &may render immediate debarment, at any given point of time.
- **13.2** Ragging in any form is prohibited and is a punishable offence as per Honorable Supreme Court directives no. "CIVIL APPEAL NO. 887 OF 2009". The Institute authorities will rusticate the student at once if found involved in ragging or promoting ragging.
- **13.3** In any issue including that dealt with above, the decision of Institute Authorities will be final.

- **13.4** Any disputes arising out of admission process will be under legal Jurisdiction of Mumbai High Court only.
- 13.5 At the time of admission the candidates have to submit an undertaking on UGC web portal –www.antiragging.in
- Note: As per University letter ref. no. দুসাবিবি/ত্বা-6.1/2806/2016 dated 2/05/2016, a candidate should complete the 4 ½ years BPO course in maximum 6 years otherwise admission shall automatically stand cancelled from the B.P.O. course as per conditions prescribed by the University and the candidate will be debarred from taking any further examinations in the B.P.O. course.
