





FIG. 1 KNEE JOINT WITH LOCK FOR STEEL ORTHOPAEOLE CALIPER AND BRACES



- 3. Material Carbon steel conforming to Designation 30 C8 or 35 C4 of IS: 1570 (Part 2)-1979 :Schedules for wrought steels: Part 2 Carbon steels (unalloyed steels) (first revision).
- 4. Workmanship and Finish The male and temale parts of joint shall be accurately and cleanly machined and the joint faces shall be finished clean and free from toolmarks. Fabrication by welding or brazing shall not be allowed. The male part shall have a close running fit with the female joint member. The outside surfaces of the joint and the shanks shall be free from lorging scales. All sharp edges and corners shall be rounded. The component shall be free from surface flaws and cracks: The ring catch shall have a close sliding fit on the rectangular section of the female joint member. There shall not be any frictional, jerky or mediciateral movements at the joints.
- 5. Marking The joint shall be marked with the following:
